

The following "Instructions to Bidders", "Specifications" and "Bid Proposal" is for equipment to be used by the Walla Walla County Road Department.

The venue and jurisdiction of any action of claim for or against the bidder or the Walla Walla County Road Department shall be in Walla Walla County and in the District or Superior Courts thereof according to the jurisdictional amount.

**INSTRUCTIONS TO BIDDERS**

These instructions to bidders are a part of the specifications.

- 1) The County must be notified at least one week prior to bid opening time of any revisions the bidder desires to have made to the detailed specifications. Any changes, additions or deletions to the specifications by the County will be made by written addendum only.
- 2) Bids will be considered final at the time and date of the stated bid opening. No changes will be allowed because of bidding errors.
- 3) Use of the enclosed bid proposal is required. Failure to use the bid proposal will constitute automatic disqualification and said bid will not be considered for award.
- 4) Reference in these specifications that are made to a particular trade name, manufacturer's catalog or model number are made for descriptive purposes only and are not meant to be restrictive but to guide the bidder in interpreting the type of material or equipment desired. They should not be construed as excluding proposals or other types of materials, equipment, and supplies or performing the work in the manner other than specified. The acceptability of any material or equipment other than that specified will be at the discretion of the County.
- 5) Bids will be F.O.B. Walla Walla County at the County's Fleet Services Yard located at 1401 Dell Avenue, Walla Walla, Washington 99362. The following documents will be furnished to the County at the time of delivery: Manufacturer Statement of Origin, Original Invoice, Odometer statement if required, and Certificate of Title Application filled out to Walla Walla County Public Works, 990 Navion Lane, Walla Walla, WA 99362. Acceptance will be after delivery to the destination.

Notification of acceptance by the County to the Bidder will be in writing. If not provided with the unit, bid payment may be withheld until all required papers are received.

- 6) Washington State Sales Tax **WILL NOT** be included in the bid. It will be added as a separate item on the invoice only.
- 7) Delivery of the units are guaranteed to be no later than 120 days after receipt of Walla Walla County's Purchase Order. Bidder will clearly indicate the time after the award necessary to make delivery of the unit, complete and ready to go at the previously assigned destination.
- 8) Bidder will attach hereto, and it will be a part of this bid, specific descriptive literature of the unit proposed for bid. Items to be furnished on this bid must be of the latest design and production.
- 9) Bidder will submit the base bid for the number of units indicated. The County reserves the right to accept or reject any or all options called for on the proposal.
- 10) The address of the bidder will be typed or printed on the Bid Proposal form.
- 11) The successful bidder shall protect, defend, indemnify and hold the County, its agents, employees, officials and officers harmless from any damages, costs, or liability for any injuries to persons or property arising from acts or omissions of the bidder, bidder's employees, agents or subcontractors, howsoever caused.
- 12) The bidder will not discriminate against any client, employee, or applicant for employment and services on the grounds of race, creed, color, national origin, sex, marital status, age or presence of any sensory, mental, or physical handicap unless based upon a bona fide occupational qualification.
- 13) If more than \$2500.00 is expended for items obtained from foreign countries, the bidder will furnish, upon completion of orders, a certificate indicating their nature and source, as required by RCW Chapter 39.25.
- 14) The prices for equipment, materials or supplies should be firm throughout the contract period with NO provision for price increases during the term of the contract unless specific provisions are proposed and agreed upon.

- 15) The bid shall be placed in a SEALED ENVELOPE marked on the outside **"SEALED BID – One (1) Used 110,000 lb.
